This year we will celebrate our 12<sup>th</sup> Annual Dinner Dance and Auction to benefit St. Dominic Outreach Center on Saturday, November 3, 2018, from 6:00-10:30pm at the beautiful Meadowbrook Country Club located on 40941 West Eight Mile in Northville.

We invite you to support St Dominic Outreach Center, either through your parish, business, organization, or as an individual patron. Your generosity and that of others across Metro Detroit is vital to the success of this Dinner Dance, our biggest fundraiser. We have been greatly blessed over the past 11 years through this event, and pray those blessings will continue.

The evening includes a buffet dinner, beer and wine, music and dancing, with live and silent auctions. **Tickets are \$75 per person and tables of 8 people are \$600 if reserved on or before September 30, 2018.**

We are a small organization but have a big impact on the lives of our brothers and sisters in the Warren and Trumbull neighborhoods. We charge no fees for providing food and sundries, good used clothing, baby cribs, holiday gifts, and more to hundreds of economically disadvantaged seniors, families, and children each month.

Every dollar raised directly benefits the people we serve. Less than \$8 fills a bag of groceries; \$150 buys a new baby crib or toddler bed; and \$1,200 purchases enough emergency food to supply those in need for three weeks.

Administrative costs for the 12<sup>th</sup> Annual St Dominic Dinner Dance are minimal because all that work is done by our dedicated volunteers.
